- 2. From ACY 2014 to 2019, the College had 288 published research works. 84 research works were cited. In ACY 2019, college had 151 full time lecturers. Therefore, the ratio of citations and number of full time lecturers was 84/151 = 0.56. The ratio was higher than the OHEC criteria. Performances originated best practices in the quality development of research works and innovations in order to be cited in published academic journals. (16.2.2)
